#### Amelia Newcomb Clinic:

- 15 rides have been paid for.
- 3 auditors have paid.
- Sue has a "tentative" schedule.
- We will start a waiting list for riders.
- Sue reported people calling, unable to be successful with signing up via Website. Kay asks those having problems to call her.
- · One person per horse per fee.
- Additional people pay auditor fee.
- Kay Turner is bringing 2 horses and paying for 2 rides. She will have a person to help her. This person does not need to pay auditor fee.
- Discussed wrist bands or tickets or some other method to identify auditors. No resolution.
- PayPal is a disconnect. Too cumbersome. The money comes in, not always clear what it is
  for and also not always the correct amount. Virginia reports to Sue that money came in. If
  incorrect, Sue has to figure it out. Paying does not mean that participants send the correct
  forms to Sue. No resolution.

- Amelia wishes to have a full size court set up, with letters. They will be filming.
- · WDAAZ has a full court, they bought for their videoing of tests.
- Amelia clinic, we will be allowed to use warm up arena. AR riders are allowed to use it also.
- Carrie has used the sound system, not the one installed in the rafter area of the arena. A set she found in storage. She has all the pieces and it works. Sherry has not seen or tested all of this but will follow up.
